## Internet Banking Agreement

- In order to participate in NetTeller, you must have at least one account at The Ohio State Bank. To participate in Net.Check you must have at least one Checking account at the Bank. All applicants must be an authorized signatory on the accounts you've requested access to. You agree that by signing this application you are requesting viewing access, the ability to transfer funds between accounts and make payments to third parties (Net.Check only) through a login ID and PIN. You will be given a PIN for accessing your bank account(s) using Internet Banking services. You are responsible for maintaining the confidentiality of your PIN in order to maintain the security of your account. The Ohio State Bank is not responsible for unauthorized disclosure of your PIN or unauthorized use of the Internet Banking services by a person utilizing your PIN. You agree to release and waive any claims against the Bank based on such unauthorized use. If there is a change of ownership or signing authority on any of the accounts(s), notification must be immediately provided to the bank.
- You have the right to terminate Internet Banking services at any time upon delivery of written notices to The Ohio State Bank. The Bank has the right to terminate its obligation to provide Internet Banking services to you upon ten days prior written notice.
- You understand and agree that any NetTeller or Net.Check transaction, which results in a negative account balance, may be refused by The Ohio State Bank.
- You agree The Ohio State Bank has the right to change the fees for Internet Banking services upon thirty days prior written notice to you. In addition, the Bank has the right to amend these rules from time to time providing you with a copy of the amended rules.
- If you are using Net.Check, you agree The Ohio State Bank shall not be responsible for any payment delays that occur for reasons beyond the bank's control.
- You agree to waive and release any claims against The Ohio State Bank arising in any way that may be related to Internet Banking services except for those claims resulting solely from the negligent acts or omissions of the Bank.
- The fees you incur for Internet access shall be your sole responsibility, as well as any additional fees that may be assessed by your Internet Service Provider and for any telephone charges that may incur.
- It is your responsibility to ensure your personal computer and related equipment are compatible and capable of operating in a manner that allows you to utilize our internet banking services.
- Net.Check is a free service; however a \$5.95 non-use fee may be assessed if there is no activity in a calendar month. *(Small Business Checking accounts will incur a \$12.95 per month fee including 30 transactions for the use of Net.Check.)*
